Scope of Work

1. Install Fiber DSHS at 4 E 3rd Avenue, Toppenish, WA 98948 to Toppenish Police Department at 1 W 1st Avenue, Toppenish, WA 98948.

Description: Install county-provided singlemode fiber on PP&L poles and terminate 4 strands at DSHS and Toppenish Police Department. Install county provided emergency wrap tags at each pole and at building egress.

- a. Use existing conduit path from DSHS equipment room to PP&L pole. Reseal building egress
 - b. Attach fiber to PP&L poles based on field survey spreadsheet. Unique installation items include: 1 push pole and one span guy pole. Install county provided emergency wrap tags at each pole and at building egress.
 - c. At DSHS location:
 - i. Provide and install locking 22 U equipment rack.
 - ii. Extend electrical circuit into equipment rack.
 - iii. Provide and install bulkhead and fiber termination panel. Route fiber into equipment rack. Terminate 4 strands of fiber.
 - d. At Toppenish Police Department location:
 - i. Attach fiber to upper parapet on roof with strain relief.
 - ii. Use existing CenturyLink building egress and internal building pathway. Route fiber to equipment room and reseal building egress.
 - iii. Use the existing fiber bulkhead. Provide and install fiber adapter units and terminate 4 strands of fiber.
 - e. Test all terminated strands and provide Yakima County Technology Services with loss results.
2. Install existing fiber to Buena Library at 801 Buena Road, Buena, WA 98921 and terminate fiber strands at Buena Water Tower at 180 Highland Dr, Buena WA

Description: Route existing fiber storage loop from pole to equipment room in Buena Library using the existing conduit from the pole to the building. Terminate 4 strands of fiber at the library and terminate 4 strands of fiber at the water tower.

- a. Route existing fiber stored on PPL pole into the library equipment room through the existing conduit between the pole and the building. Reseal building egress.
- b. At Library Location:
 - i. Provide and install locking 22 U equipment rack.
 - ii. Extend electrical circuit into equipment rack.
 - iii. Provide and install bulkhead and fiber termination panel. Route fiber into equipment rack. Terminate 4 strands of dark fiber. **sheathe includes 4 strands to lit fiber. All strands pass through without interruption except 4 dark fiber to be terminated in Library.**
- c. At Buena Water Tower Location:
 - i. Use the existing fiber bulkhead. Provide and install fiber adapter units and terminate 4 strands of fiber.
- d. Test all newly terminated strands and provide Yakima County Technology Services with loss results.
