



YAKIMA COUNTY INTERLOCAL AGREEMENT

THIS INTERLOCAL AGREEMENT is entered into between YAKIMA COUNTY, Washington (hereinafter referred to as the "County"), whose address is 128 North Second Street, Yakima, Washington 98901, and the <u>Yakima Valley</u> <u>Regional Library</u> whose address is <u>102 N. Third St., Yakima WA 98901</u>, (hereinafter referred to as "<u>Library</u>") pursuant to Chapter 39.34 RCW.

WITNESSETH:

In consideration of the terms and conditions contained herein, the parties hereto agree as follows:

- The County agrees to provide the <u>Library</u> with "best effort" access to 9mb of internet bandwidth on a month to month basis.
- II. The <u>Library</u> agrees to contract monthly at rate of \$766.19 per month. The County may adjust the rates as necessary with 30 (thirty) day written notice.
- III. The <u>Library</u> shall not be prohibited from implementing its own security in the form of a firewall or proxy server, if it is deemed necessary, provided that said security does not interfere with the County's equipment or services.
- IV. Yakima County Director of Technology Services is authorized to sign the this form on behalf of the Yakima County Commissioners.
- V. Each party agrees that it shall not discriminate against any person on the grounds of race, creed, color, religion, national origin, sex, age, marital status, political affiliation or belief, or the presence of any sensory, mental or physical handicap in violation of the Washington State Law Against Discrimination (R.C.W. Chapter 49.60) or the Americans with Disabilities Act (42 U.S.C. 1201 et seq.) or any other applicable state, federal or local law, rule or regulation.
- VI. Neither party shall assign any portion of the contracted activities without obtaining prior written approval from the other party.
- VII. Either party may terminate this contract upon fifteen (15) days written notice sent to the address listed above.
- VIII. Except as provided herein, each party shall indemnify and hold harmless the other party, its officers, agents, and employees, from all liability, loss or damage, including costs of defense that may suffer as a result of the claims, demands, actions, damages, costs or judgments which result from the actions performed by the indemnifying party, its agents, employees, or subcontractors pursuant to this Agreement.

- IX. YAKIMA COUNTY DISCLAIMS ALL WARRANTIES BOTH EXPRESSED AND IMPLIED, INCLUDING IMPLIED WARRANTIES RESPECTING MERCHANTABILITY, TITLE, AND FITNESS FOR A PARTICULAR PURPOSE. YAKIMA COUNTY ACCEPTS NO LIABILITY RESULTING FROM DELIVERY OR NON-DELIVERY OF SERVICES OR FOR DAMAGES TO ANY EQUIPMENT OWNED OR OPERATED BY THE CITY OR ANY OTHER PERSON OR FOR ANY CONSEQUENTIAL DAMAGES INCLUDING LOSS OF PROFITS OR LOSS OF USE OF ANY PROPERTY. THE CITY ACKNOWLEDGES THAT ITS ONLY REMEDY FOR FAILURE OF ANY SERVICE OR EQUIPMENT PROVIDED FOR HEREIN IS CANCELLATION OF THIS AGREEMENT
- X. This Agreement shall be governed by the laws of the State of Washington. Any action suit or judicial proceeding for the enforcement of this Agreement shall be brought in the Superior Court for the State of Washington in Yakima County, Washington.
- XI. The term of this agreement shall be from the date of execution until canceled as provided herein.

STATEMENT OF WORK

Amended 7/19/07

Provide secure server environment along with 100 MB of Ethernet bandwidth to connect from the Yakima County Secure Data Center (SDC) to the down town Yakima Regional Library building (YVRL).

YVRL is to purchase and install the server rack. Yakima County will specify rack, location and method of mounting.

Yakima County Technology Services to provide one instance of virtual firewall with a basic construct for library use as a best effort service. Library will finish the configuration and administer the firewall for their use. Basic training will be provided regarding access and use of the firewall. Training will be one time and provided to library's designee by T.S. firewall administrator. If additional support or training is required they may be provided at the hourly network administration rate.

Addendum

This Addendum is hereby attached to and made a part of the Inter-local Agreement (the "Agreement") by and between Yakima County Technology Services and the Yakima Valley Regional Library (YVRL).

The Agreement is hereby amended, modified, and revised as follows:

- 1. The parties acknowledge and agree that the access to, and use of, certain facilities within the YVRL Main Branch-Yakima for purposes of providing network transport, are of mutual benefit. Said network facilities shall serve to allow fiber optic transport to, and for, Yakima County business operations at the Liberty Building, Yakima, WA.
- 2. Yakima County Technology Services agrees to carry and provide access to those YVRL VLAN's (Virtual Local Area Network's) that reside within Yakima County network transport infrastructure in order to allow YVRL to conduct business at this same location.

The parties have executed this Addendum as of the 10th day of March 2009.
